### Qualification of Applicants

1. Hold a Doctor of Dental Surgery (DDS) or Bachelor of Dental Surgery (BDS) or Doctor of Medicine in Dentistry (DMD) degree with GPAX at least 2.5 from the University accredited by the Ministry of Education and/or the Dental Council of Thailand.
2. Hold a valid Dental License from Thai Dental Council.
3. Obtain at least one year of working experience in dental practice. (from license granted date to the end of application date)
4. CU-TEP score of at least 55 or TOEFL ITP score of at least 470 or iBT score of at least 47 or IELTS score of at least 4.5, taken within 2 years. **The examination scores must not exceed more than 2 years since the report date until the announcement of exam results. The test scores must be valid for at least 2 months in order to be approved by the Faculty Executive Committee.**
5. Possess qualifications complied with those announced by the Graduate College (to be announced yearly).
6. The Program Administrative Committee reserves the rights to consider other qualifications that deem appropriate to be eligible for admission application.

### Application documents

1. Certified copy of degree certificate. A certified copy of academic transcript stating the graduation with Doctor of Dental Surgery or Bachelor of Dental Surgery or Doctor of Medicine in Dentistry degree from the University accredited by the Ministry of Education and/or the Dental Council of Thailand, and any higher degree(s) in dentistry. (Certified copy with applicant's signature is acceptable).
2. Result of English Proficiency test taken within 2 years (Certified copy with applicant's signature is acceptable).
3. Copy of identity card or government identification card (Certified copy with applicant's signature is acceptable).
4. Certified copy of Thai dental practice permit. (Certified copy with applicant's signature is acceptable).
5. At least one reference letter of working experience in dental practices.
